Promotion runs July 15, 2020 – September 1, 2020.

Official Rules:

1. **Description:** The Plastic Oceans Foundation Canada (POFC) “Win a 5-Day Expedition with Plastic Oceans Canada” begins at 12:00 a.m. PST on July 15, 2020, and ends at 11:59 p.m. PST on September 1, 2020 (the “Entry Period”). Entries submitted outside the Entry Period are void. The sponsor of this Promotion is POFC.
2. **Eligibility:** The Promotion is open to legal residents of any one (1) of the ten (10) provinces or three (3) territories who are at least 18 years of age and at least the age of majority in their province or territory of residence on the date of entry. To be eligible to win a prize, entries must be completed and received by POFC in the manner and format designated below. Directors, officers, and employees of POFC and any of its parent companies, affiliate companies, subsidiaries, agents, professional advisors, advertising and promotional agencies, and immediate family members of each are not eligible to win any prizes.

4. **Entry:** To enter the Promotion, participants can do one of the following:
 - a. **Bottle Drive Fundraiser:** Donate the refund from returned bottles and cans to POFC by September 1, 2020. Participants must state the number of bottles and cans in the Message section of the donation form. A prize will be awarded to the

participant that raises the largest sum of money through the Bottle Drive Fundraiser.

- b. Scavenger Hunt:** Complete the POFC Scavenger Hunt and submit the completed form to citizenscience@plasticoceans.ca by September 1, 2020. Include the participant's name and contact information on each submitted form. A prize will be awarded to the participant that collects the most pieces of plastic on their Scavenger Hunt.

Entries are limited to one entry per person. POFC reserves the right not to consider for the Promotion any entry it deems, in its sole determination, to be inappropriate or ineligible.

POFC reserves the right to disqualify, in its sole discretion, any Entries that appear to be generated by a macro, script or other automated means.

- 5. Prizes:** Two (2) prizes will be awarded, one (1) for each method of Entry. Prizes will be awarded by September 15, 2020. Each prize consists of one (1) 5-day excursion for two (2) to Vancouver Island as advertised here: <https://plasticoceans.org/vancouver-island-expeditions-2021/>. Each prize is all inclusive from the Greater Vancouver area. The estimated retail value of each prize is US\$3,200. Prize is transferable: assignment or substitution is permitted.
- 6. Odds of Winning; Taxes:** Odds of winning a prize depend on the number of eligible entries received. Prize winners are solely responsible for all taxes, registration, title, fees, license duties, insurance and all expenses in claiming, registering and using their prize. This may include sales taxes and property taxes. POFC has no liability with regard to taxes and fees for the prizes.
